**MODIFICATION OF PROTECTIVE COVENANTS
OF
RIVER OAKS PHASE VII SUBDIVISION**

WHEREAS, the undersigned are the owners of all of the lots in River Oaks Phase VII Subdivision in the City of Heath, Licking County, Ohio; and

WHEREAS, all of the lots in River Oaks Phase VII Subdivision are encumbered with protective covenants, which are recorded at Instrument Number 200302190007697 in the Office of the Recorder, Licking County, Ohio; and

WHEREAS, the protective covenants contain the following provision:

12. Portable Buildings. No buildings, partially completed buildings, or other structures shall be moved onto any lot in said subdivision from an outside location, unless approved by the Developer in the manner provided in Paragraph 26 of these restrictions and unless said building is in conformity with the design standards contained in these restrictions. There shall be no outside storage building allowed.

WHEREAS, the undersigned desire to modify the protective covenants pertaining to Phase VII of River Oaks Subdivision as provided herein;

NOW, THEREFORE, in consideration of the mutual benefits to be realized by all of the undersigned, the undersigned agree as follows:

a. That Covenant Number 12 for River Oaks Subdivision, Phase VII, is modified to delete the last sentence thereof.

b. That the following Covenant Number 31 be added to the Protective Covenants for River Oaks Subdivision, Phase VII:

31. Amendment. These protective covenants may be amended at any time by an instrument in writing executed by the Owners of a majority of the total number of lots in this Phase VII subdivision.

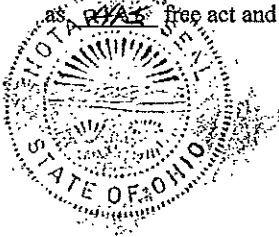

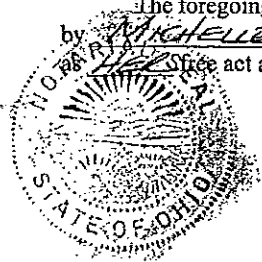

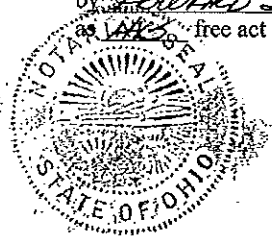
